A barrister who is an authority in SDLT will be able to advise on all aspects of your correspondence with HMRC. None would disagree that some at least of the complexity of the UK tax system is due to an 'arms race' between HMRC and the taxpayer and is provoked by attempts to secure the tax base from creative tax avoidance structures. Tax law 'floats' above the general law and makes use of general legal concepts as well as tax specific ones. In applying a tax statute, one will often be looking at general law concepts that the tax statute makes use of. Many tax barristers have expertise in all direct tax matters and are also experienced VAT and SDLT practitioners. Several United Kingdom tax barristers are able to undertake tax arbitrations either as counsel or arbitrator. Some barristers have a broad practice encompassing both litigation and investigations.



A barrister who is an authority in SDLT may be able to advise how particular transactions can be structured. More than a few UK tax barristers represent clients in the Court of Justice of the European Union (CJEU) and occasionally in other jurisdictions such as Hong Kong, Mauritius and Singapore. People using tax barristers should provide as much supporting documentation as might be relevant (eg sets of accounts, key contracts, correspondence). ## **The Tax Machine**

*It is vital to realize that flat taxes are not really about just having one rate of income tax or about tax simplification. They're about limiting the power of democracy and letting markets run riot without any ability to constrain the consequences. Prospective tax barristers should also be prepared for working long, often unsociable, hours in their early careers as they work to establish themselves. However, the rewards can be high in this profession and remuneration for successful barristers can be significant. Property development and investment (including advice on ATED) are matters that a barrister focused on tax can give advice on. A handful of proficient barristers advise on both direct and indirect taxes whether they be taxes on income, capital, turnover or otherwise. In addition to acting on behalf of clients in the usual Counsel capacity, advising on the merits of a case, drafting documents and providing advocacy services, clients have direct access to the specialist expertise of a barrister at all stages of a tax dispute. The opinion of a [Domicile Advice](#) service should be sought if clarification of the finer issues are required.*

*Those who do not want the tax system to work as it should are called tax abusers, although it should be said they come in two distinct varieties. The first lot are tax avoiders and the second lot are tax evaders. Barristers need to have good powers of persuasion, whether oral or written, and to be able to explain complex issues so that their clients, members of a jury or other non-specialists are able to follow the argument clearly. Many an accomplished barrister is known for their effective advice to taxpayers on a wide range of corporate tax issues. The best tax barristers regularly deal with domestic and cross-border investigations. Pensions barristers analyse and advise on the legal aspects of the employer covenant and work with employer covenant advisers to help sponsors and trustees get a complete picture. ## **Wider Tax Policy**

*Although most UK tax barristers focus on UK tax, international tax is an important dimension to most tax practitioners' work, and covers double tax treaties and EU law. Tax specialists may have worked on a wide range of transactional and advisory roles, both domestic and international, covering income tax and capital gains tax, corporation tax, VAT and stamp taxes. Pensions is a technical and specialist area of law and not all full service law firms have a dedicated pensions team. Stamp Duty Land Tax is payable on commercial property purchases and leases. Calculating SDLT on commercial leases can be extremely complex, often leading to overpayment of the tax. The reclaim process in such cases can also be complicated and time-consuming. Clients with business interests and personal wealth in the US and the UK are required to navigate two complex and very different tax systems. Successful wealth planning for such clients requires the lead advisor to be "ambidextrous" in that they understand the tax treatment of a proposed transaction in both countries simultaneously. Advisory services such as [Inheritance Tax Advice](#) are a common sight today.*

*The top tax barristers regularly advise on the taxation of trusts and estates, charities and associations, and property, and are experienced advocates before the First-tier Tribunal (Tax), the Upper Tribunal and the courts.
